Anthem Blue Cross makes more contract changes







Be on the lookout for another letter from Anthem Blue Cross announcing contract changes for their PPO providers. Currently, providers have one year to bill a claim for a PPO patient (90 days for HMO patients). Anthem is changing this to only 90 days from the date of service for PPO patients.. If you do not submit your claim within 90 days, Anthem will deem the claim as being submitted untimely and they will refuse payment.

The letter announcing this change is dated June 21, 2019. It was not sent by certified mail, so can be easily overlooked in your office. The letter gives an example that states for PPO patients seen on or after July 5, 2019, you will have to submit the bill within 90 days to be paid. In addition, the letter requires you to respond to a request for more information either within the 90 days or within 60 days of the request for more information.

COA is working with CMA Legal Counsel to investigate whether this notice meets California law and gives providers the required notice prior to implementation. We will update you if there is a change to the Anthem Blue Cross implementation date.

HIPAA: OCR releases new FAQs clarifying disclosures amongst covered entities

On June 26, 2019, the Department of Health and Human Services Office for Civil Rights (OCR) issued two new FAQs that clarify:

- 1. The parameters around covered entities sharing protected health information (PHI) for a recipient covered entity's health care operations: and
- 2. That once a covered entity receives PHI under HIPAA, the recipient covered entity may use and disclose it without individual authorization in any way permitted by HIPAA (even if different than the reason the covered entity initially received the PHI).

These FAQs, although focused on health plans, clarify for all covered entities the types of disclosures of PHI that are permitted for a recipient covered entity's health care operations and that a covered entity is not restricted by HIPAA to only using and disclosing PHI for the purpose it was initially received. Despite concerns about physicians' workload associated with electronic health records (EHRs), little attention has been paid to the relationship between physicians' well-being and the in-basket messages physicians receive — specifically, their volume and sources. Receiving more than the average number of system-generated in-basket messages was associated with 40 percent higher probability of burnout and 38 percent higher probability of intending to reduce clinical work time. Surgeons should educate each other on the hip-spine connection


