# **DWC Updates the OMFS for Physician and Non-Physician Services (treatment fee schedule) Effective January 1, 2022**

The Division of Workers' Compensation (DWC) has updated the Official Medical Fee Schedule (OMFS) for Physician and Non-Physician Services to include the 2022 CMS Medicare updates. Unlike CMS, the DWC does not calculate the reimbursement amount for each CPT code based on your geographic location. COA provides this service.

# Physicians Need to Know about Upcoming Musculoskeletal Guideline Changes for 2022

The American Medical Association (AMA) provides Current Procedural Terminology (CPT®) code and guideline changes to the CPT Manual each year. In the October issue of AAOS Now, members received a sneak preview of new and revised codes to the Musculoskeletal section for the 2022 CPT code set. ### AB 1400 — Single-Payor Bill Passes the Assembly Health Committee

As of January 1, 2022, the California State Legislature begins the second year of its two-year legislative session. As such, bills that were introduced in 2021 must move through the Legislative process in January in order to stay alive. AB 1400, the bill proposing a single payor system for California, is one of those bills.

So, due to these deadlines, members were pressured to support AB 1400 and allow it to move forward. The bill passed its first legislative committee this week – the Assembly Health Committee. The primary author of AB 1400 is Ash Kalra (D-San Jose). The principal coauthors of AB 1400 are Phil Ting (D-San Francisco), Isaac Bryan (D-Baldwin Hills), Wendy Carrillo (D-Los Angeles), and Senators Lena A. Gonzalez (D- Long Beach), Mike McGuire (D-Healdsburg), and Scott Wiener (D-San Francisco). The bill is also coauthored by Assemblymembers Laura Friedman (D-Glendale), Kevin McCarty (D-Sacramento), Adrin Nazarian (D-Van Nuys), Luz Rivas (D-Arleta), Mia Bonta (D-Alameda), and Buffy Wicks (D-Oakland), and Senators Josh Becker (D-Peninsula), Dave Cortese (D-Silicon Valley), John Laird (D-Santa Cruz), Sydney Kamlager (D-Los Angeles), and Bob Wieckowski (D-Fremont). Several members they reserved the right to vote "No" on the bill, but voted "Aye" in the Health Committee to allow the bill to move forward.

Health care providers, including COA and the California Medical Association are opposed to AB 1400, although the California Nurses Association is in support.

The bill is very controversial and funding for universal health care remains a significant challenge for the bill, although a tax increase is being proposed to fund the plan. It is estimated to cost each household in California \$12,000 per year.

This is just the first step for the bill in the Legislative process. COA will keep you informed and alert you when there are opportunities to provide input.

### Budget Proposal Positions CA To Be First State To Achieve Universal Health Care Access and Coverage

Governor Gavin Newsom has released his initial proposal for the 2022-23 California state budget. The Administration remains committed to access to care for all Californians, dedicating more than 22% of both the General Fund and total budgets to health expenditures. Notably, the Governor has proposed a phased-in system to provide full scope Medi-Cal coverage to all income eligible Californians regardless of age or documentation status by January 1, 2024. The proposal also maintains full funding for the Proposition 56 (tobacco tax) supplemental payments, including a \$176 million General Fund backfill of the payment program due to the declining revenues from cigarette taxes.

As part of its ongoing efforts across many channels to expand Americans' access to free testing, the Biden-Harris Administration is requiring insurance companies and group health plans to cover the cost of over-the-counter, at-home COVID-19 tests, so people with private health coverage can get them for free starting January 15th. The new coverage requirement means that most consumers with private health coverage can go online or to a pharmacy or store, buy a test, and either get it paid for up front by their health plan, or get reimbursed for the cost by submitting a claim to their plan. This requirement incentivizes insurers to cover these costs up front and ensures individuals do not need an order from their health care provider to access these tests for free.
