Workers' Compensation Guidance

DWC Posts Proposed Amendments to Medical-Legal Fee Schedule

The Division of Workers' Compensation

The Division of Workers' Compensation has posted proposed changes to the Medical-Legal Fee Schedule. The changes propose an entirely new flat-rate system for reimbursing physicians for evaluations and other Medical-Legal services. For example, DWC is proposing that the flat rate for a Comprehensive Medical-Legal Evaluation is \$2,015 and would include review of 200 pages of records. Additional records would be reimbursable at a per page rate. The proposed implementation date is January 1, 2021.

COA leaders participated in a DWC Work Group last Fall that helped develop the framework for these changes. We support the proposal as a good first step in updating the Medical-Legal Fee Schedule. COA will continue to work with the Division to refine the proposal.

The Public Forum is just the first step in revising the Medical-Legal Fee Schedule. The proposed changes will still need to go through a formal regulatory rule-making process.
