#### **Dignity and Anthem Blue Cross Reach Agreement**

Agreement Is Retroactive To Avoid a Disruption in Network Access

Faced with reports of rogue physicians selling bogus mask exemptions, the Medical Board of California has issued a statement informing licensees that physicians who grant a mask or other exemption without conducting an appropriate prior exam and without a finding of a legitimate medical reason supporting such an exemption within the standard of care may be subject to disciplinary action.

#### Orthopedic Surgeon Pay Per wRVU Up 11.36% in 2020

Orthopedic surgeons reported a steep drop in work relative value units, but the compensation per unit increased, according to AMGA's 2021 Medical Group Compensation and Productivity survey. The wRVU for orthopedic surgeons was down 14.84 percent in 2020 from 2019. Compensation per wRVU increased 11.36 percent, meaning overall pay dropped less than 1 percent in 2020. Pay among all surgical specialties was up 1.95 percent on average, and median wRVU decreased 11.97 percent. The large declines in wRVU reflect canceled surgeries during the COVID-19 pandemic. Overall, half of physicians said guaranteed compensation was reduced, and 25 percent said they received advanced salaries that would be balanced later.

# UnitedHealthcare Guided Yale's Groundbreaking Surprise Billing Study

In 2016, an academic study from some of the most respected scholars in health care economics prompted a national outcry. The study, published in the *New England Journal of Medicine* by Yale University researchers, found that 22% of the time someone goes to an emergency room in a hospital covered by their insurance, they still receive costly bills after being treated by an out-of-network doctor. The practice, known as "surprise billing," saddles Americans with thousands of dollars in debt per year. The researchers went on to find that surprise billing was not only relatively common, but also a tactic that private equity-owned hospital staffing companies had employed to increase revenue. According to their findings, when either of the country's two largest staffing companies took over a hospital's emergency department, out-of-network charges soared. The research was based on data from more than 2 million claims provided by UnitedHealthcare, the largest private health insurance company in the United States, under a data sharing agreement with Yale.
