# **IMPORTANT COVID INFORMATION** Mandatory Testing of Healthcare Workers



The California Department of Public Health implemented new State Public Health Officer Orders on July 26, 2021 and August 5, 2021 that require healthcare workers to be vaccinated against COVID-19 by September 29, 2021. In compliance with this new order, COA is making available sample policies/templates that you may want to use in your practice.

The templates have been prepared and approved by the labor and employment firm Fisher & Phillips LLP. We thank Grace Y. Horoupian, Esq., for sharing the templates for distribution to COA. Should

# Payers Shifting Strategy To Keep Physicians Independent

Blue Cross Blue Shield of Michigan added a physician management services business to its portfolio in early August, following a trend of insurance companies seeking to partner with or employ physician groups to keep them independent of

hospitals. The payer announced the purchase of an unnamed Royal Oak, Mich.-based physician practice management service organization Aug. 11. The company delivers business support to independent physicians transitioning to value-based care models.

# ACOs Earned \$2.3B in Shared Savings Bonuses Last Year: CMS

ACOs participating in the Medicare Shared Savings Program in 2020 earned performance bonuses totaling nearly \$2.3 billion and saved Medicare \$1.9 billion, CMS said Aug. 24. CMS said 345 out of 513 ACOs, or 67%, earned shared savings payments in 2020, but the data shows that ACOs participating in downside risk models were more likely to earn the bonus payments. In particular, 88% of the two-sided risk models and 55 percent of one-sided risk models earned the performance payment.
